- **Funding for Research Support for Graduate Students:**
  - a. **Support for Data Purchase:** PER will provide support for students who wish to purchase data sets for their Ph.D. research. To apply, a student must submit a 5-page research proposal detailing the use of data for his/her research, accompanied by letters of endorsement by two advisors. The funding will be conditional on the research carried out not being co-authored with advisors; and the funding decision will take favorably into account a proposal that will make the data available for other students and has the advisors offering to match a share of the expense.
  - **Student Editing Support Program:** PER will provide \$500 per person during the program for English editing services, under the condition that the sponsoring faculty member(s) match the PER contribution.
  - **Fly-Out Assistance:** PER will provide support to job-market candidates who need assistance traveling for interviews.
  - **Conference Travel:** PER will reimburse 50% of conference-related expenses up to a maximum commitment of \$400.
  - **Faculty | Student Lunch:** PER will help cover the costs of faculty –student lunch with 1<sup>st</sup> year Ph.D. students. Each lunch should have 2-5 students, and at least one of you. PER will reimburse \$20 per person (excluding tax and tip). You will cover any overage. You can submit a regular reimbursement request indicating that the expense is for a “1st year students-faculty lunch”. Each of you is most welcome to host multiple such lunches, but please do not repeat the same group of students.

- **Summer RA Support Program:** PER will award up to 20 summer RA grants of \$2,000 each for Ph.D. students working with a faculty in the department. The Call for Proposal will be distributed in Spring 2019.
  
- **Working Paper Series (Online)**
  - **The Columbia Economics Discussion Paper (DP) Series:** The DP series will publish faculty research at the pre-publication stage. (Columbia Ph.D. candidates at an advanced stage, typically in the job market year, may publish papers in the DP series with the endorsement of at least two faculty members within the Department.)
